MoLA's Replies to Request for clarifications

RfQ 1. Is the training in Arabic or English?

Reply 1:

- (a) The training in classroom (CS), workshop (WS), and on-the-job (OJB) will be in Arabic.
- (b) The training abroad (TV) will be provided by Host operators (SWM facilities' operators, TS operators) located in European countries in English. In those trainings, where the Trainer's role will be complementary (ref. to RFP/Section III §2.2), the language used between the Trainer and the Host will be English, whilst between the Trainer and the Trainees will be Arabic.
- (c) The Training material to be submitted by the Training Services Provider (TSP) to the Client for review and approval prior to the commencement of the Training performance, shall be in English. The Training material to be made available to the Trainees will be in Arabic.
- (d) The tender Proposal, as well as all correspondence and documents relating to the Proposal exchanged between the Bidder and the Client shall be in English (ref. to RFP/ Section I clause 9).

RfQ 2. What are the trainers' backgrounds: Qualifications? Titles?

RfQ 3. Where does the training take place?

RfQ 5. According to 15.2 Only one Trainer CV shall be submitted per one lot. Do we have to designate (16) different trainers for (16) LOTS?

Reply 5: Please refer to the RFP/ Section III - §5.2.1 ("A Trainer may be nominated for more than one LOT provided that...").

RfQ 6. Will we submit the Performance Security guarantee along with technical & financial or when we receive the receipt of the Letter?
