Question #1. On Page 93, section 5.1 Training service Provider, can you please clarify what is a valid classification certificate.

Reply #1. Valid classification certificate for Training Sservice Provider is the Trade registration certificate.

A Valid classification certificate for Trainers set out in clause 5.2.1 / Page 93, is the professional certificate including practicing certificate (as appropriate) issued by the competent professional association.

Question #2. If the service provider does not have an ISO 9001 certificate (or equivalent), will the lack of provision an ISO certificate (or equivalent) will result in disqualification.

Reply #2. Valid Quality certificate is required under penalty of disqualification. A Training Service Provider is considered to meet the requirement and shall be qualified for this tender if it holds any of the following valid Quality documents:

- ISO 9001 certificate or equivalent;
 - A company Quality regulation that has been drawn up by the Training Center based on the provisions of international quality standards and which is demonstrably applied by the Training Centre.

Question #3. can one trainer be proposed for multiple training positions for different LOTs?

Reply #3 A trainer may be nominated for different LOTs under the conditions (a) his/her qualifications meet the requirements of the concerned LOTs specified in Section III/ToR/sub-section 5.2; and (b) his/her availability to provide training services in the concerned LOTs is consistent with the dates for performance of the Training Modules in the LOT's Training Plan proposed by the Bidder in accordance with Section III/ToR/sub-section 2.2 – item (4).
